6. Two passport size photographs one duly attested by the gazetted officer and other one unattested which were uploaded at the time of online submission of Application.

**IMPORTANT INSTRUCTIONS:-**

**The Purpose of calling for checking of testimonials is only to check/verify claim of a candidate to the particular category, Qualification and age etc. Mere calling for checking of testimonials/interaction does not mean that he/she has been selected, it is only for administrative purpose.
