- Cases upto the year 1990, cases relating to Senior Citizens, Crime against Women, differently abled persons, Juveniles, Marginalized Sections of society, Prevention of Corruption Act, cases in which proceedings before lower Courts have been stayed and remand cases from Hon'ble the Supreme Court will be taken up on priority basis.
- Ordinarily filed RSAs up to the year 2018 wherein notice is yet to be issued will be shown in urgent list.
- All previous orders in respect of earlier Roster stand superseded.
- Specially constituted Benches to hear murder references along with Criminal Appeals shall continue.
- Special DB comprising of Hon'ble Mr. Justice Jitendra Chauhan and Hon'ble Mr. Justice Harminder Singh Madaan to hear the old Criminal appeals shall continue to meet as per the pervious arrangement.
