

Hon'ble the Chief Justice has been pleased to order that during ensuing Diwali Break 2022 w.e.f. 22.10.2022 to 26.10.2022, Anticipatory Bail Applications, cases relating to Life and Liberty (Protection matters of Runway couples) and 'any other Urgent Matters', as may be permitted by Hon'ble the Senior most Vacation Judge through Registry; will be entertained on 25.10.2022 and 26.10.2022.

Habeas Corpus Petitions will also be entertained from 22.10.2022 to 26.10.2022.

Anticipatory Bail Applications and Protection matters of Runaway Couples filed on 20.10.2022 (after 12.00 Noon) and on 21.10.2022 (before 12.00 Noon) wherein request for listing the same during Diwali Break is made, will be listed during Diwali Break on 26.10.2022.

2. Request for listing the case for the same day or next Court working day in case of Anticipatory Bail Applications and Protection matters of Runaway Couples as well as taking up of any other Urgent Matters including Division Bench

matters, if any, will be made before Hon'ble the senior most vacation judge available on the dates mentioned only on Court Working days.

3. No filing except Caveat Application u/s 148-A CPC and cases in which mentioning for listing the case on 25.10.2022 and 26.10.2022 has been allowed by Hon'ble the senior most Vacation Judge will only be entertained during Diwali Break on 25.10.2022 and 26.10.2022.

However, Habeas Corpus Petitions will be entertained without mentioning during Diwali Break from 22.10.2022 to 26.10.2022.

4. The fresh **Subsequent Bail Applications** will be listed during Diwali Vacations only subject to the availability of the Hon'ble Judge who decided the earlier Bail Application.
