2. **Mentioning:**
Mentioning of all type of matters (whether freshly instituted or applications in pending matters) will be made before Hon'ble the Senior most Vacation Judge during Summer Vacations from 03.06.2023 to 01.07.2023.
3. **Filing:**
All the matters will be accepted for filing during Summer Vacations from 03.06.2023 to 01.07.2023.
4. **Listing:**
 - (i) All the Urgent Criminal matters accompanied with an Urgent Form and 'any other matter' as permitted by the Hon'ble Senior most Vacation Judge filed on working days upto 12:00 noon will be listed after a gap of one working day. The matters filed on working days after 12:00 noon will be listed after a gap of two working days.
 - (ii) The First Regular Bail Application(s) or Suspension of Sentence Application(s) accompanied with an Urgent Form praying for listing the matter during Summer Vacations will be listed after issuance of advance notice to State as per prevalent practice.
 - (iii) The '*Subsequent Bail Application(s) of same accused*' or '*Cancellation of Bail Application(s)*' or '*Application(s) in Decided Case(s)*' will be listed during Summer Vacations only subject to the availability of the Hon'ble Judge who decided the previous Bail Application or main case, as the case may be.
5. Hon'ble Vacation Judges will also attend election work, if any, fixed during the Summer Vacations from 03.06.2023 to 01.07.2023.
