9	Repair of electronic circuit (PCB) in window/split AC.	
10	Repair of fan motor in window type air conditioner	
11	Repair of fan motor in outdoor unit of split type air conditioner.	
12	Replacement of compressor in 1.5 ton Split/window AC	
13	Replacement of compressor in 2.0 ton Split/window AC	
14	Drain tray for window AC (Small & Big)	
15	Replacement of condenser coil of AC	
16	Replacement of compressor in mini refrigerator.	
17	Replacement of relay and OLP in mini refrigerator.	
18	Replacement of thermostat in mini refrigerator	
19	Repair/replacement of freezer in mini refrigerator.	
20	Refilling of refrigerant in mini refrigerator.
