No case may be fixed in motion hearing on Wednesdays. However, cases already fixed in ordinary motion hearing on this day will be taken up as usual.
2. Hon'ble Judges sitting in Hon'ble Division Benches after exhausting their lists may sit singly for taking up Single Bench cases.
3. Special Benches will take up the cases on all Fridays.
4. All mentioning of fresh urgent cases in Civil matters, Writ Petitions and LPAs will be made before Hon'ble the Acting Chief Justice and in Criminal matters mentioning will be made before Hon'ble the First Puisne Judge except the cases which are listed in motion/regular hearing before the Hon'ble Benches and the same would be made before the said Hon'ble Bench.
5. Cases relating to Senior Citizen, Crime against Women, Person with Disability, Children, Juvenile, Marginalized Section, Prevention of Corruption Act, Cases in which proceedings before the lower Courts have been stayed and Remand cases from Hon'ble Supreme Court will be taken up on priority basis.
