

Hon'ble the Chief Justice has been pleased to order that during ensuing Winter Break 2022 w.e.f. 24.12.2022 to 03.01.2023, First Anticipatory Bail Application, Cases relating to Life and Liberty (Protection matter of Runway couples) and 'any other Urgent Matter' as may be permitted by Hon'ble the Senior most Vacation Judge through Registry; will be entertained on 26.12.2022 to 28.12.2022, 30.12.2022 and 02.01.2023 and 03.01.2023.

Habeas Corpus Petitions will also be entertained from 24.12.2022 to 03.01.2023.

1. First Anticipatory Bail Applications and Protection matters of Runaway Couples filed upto 12.00 Noon will be listed after a gap of one working day and the said cases filed after 12.00 Noon will be listed after a gap of two working days.

First Anticipatory Bail Applications and Protection matters of Runaway Couples filed on 22.12.2022 (before 12.00 Noon) wherein request for listing the same on 26.12.2022 is made on Urgent form will be listed on 26.12.2022.

First Anticipatory Bail Applications and Protection matters of Runaway Couples filed on 22.12.2022 (after 12.00 Noon) and on 23.12.2022 (before 12.00 Noon) wherein request for listing the same during Winter Break is made, will be listed during Winter Break on 27.12.2022.

2. Request for listing the case for the same day or next Court working day in case of First Anticipatory Bail Applications and Protection matters of Runaway Couples as well as taking up of 'any other Urgent Matter' including Division Bench matters, if any, will be made before Hon'ble the Senior most Vacation Judge available on the date mentioned only on Court Working days.
3. No filing except First Anticipatory Bail Application, Protection matter of Runaway Couples, Caveat Application u/s 148-A CPC and cases in which mentioning for listing the case during Winter Break has been allowed by Hon'ble the senior most Vacation Judge will only be entertained during Winter Break from 26.12.2022 to 28.12.2022, 30.12.2022, 02.01.2023 and 03.01.2023.

However, Habeas Corpus Petitions will be entertained without mentioning during Winter Break from 24.12.2022 to 03.01.2023.

4. The fresh **Subsequent Bail Application** will be entertained and listed during Winter Break only subject to the availability of the Hon'ble Judge who decided the earlier Bail Application.
