2. Each bidder will submit a Certificate issued by Govt. For disposal of e-waste material alongwith the proposal.
3. The successful bidder will have to deposit the full amount within a week or before lifting the articles whichever is earlier otherwise the proposal will be treated as cancelled and the successful bidder will have no right whatsoever after that.
4. The successful bidder will have to lift the articles within a week of the intimation by this Court at his own expense after which he will have no right over the above mentioned items.
5. The successful bidder will ensure disposal of the IT material in terms of e-waste disposal policy and will submit a certificate in this regard before lifting the articles.
6. No manpower will be provided for lifting the above items.
7. This Court reserves the right to accept or reject any or all the quotations received without assigning any reason thereof.
8. The abovementioned articles shall be available on inspection from 28th July 2023 to 1st August 2023 on working days between 11:00 AM to 4:00 PM in the store of Computer Branch.
9. The word **"QUOTATION FOR DISPOSAL OF OLD UNUSABLE IT MATERIAL"** should be inscribed on the sealed envelope.
10. Offers should be neatly typed or handwritten. There should be no overwriting additions etc. Alterations if any should be attested by the participating bidders.
11. The quotations received after due date will not be considered.
