

**PUNJAB AND HARYANA HIGH COURT, CHANDIGARH**

**REVISED AUCTION NOTICE**

Auction for the disposal of 691 old/ unserviceable tyres of the Official/ Staff cars of this Court, earlier fixed for 15.02.2020 at the Old District Court Building, Sector - 17, Chandigarh, will now be held on 29.02.2020 at 12:00 noon, at the Old District Court Building, Sector - 17, Chandigarh.

The type/ size/ category of the tyres, available for auction are as under:

All the scrap/ junk dealers of the tricity are invited for participating in the Auction of the old/ unserviceable tyres of this Court as mentioned in the above list, by depositing the earnest money of Rs.10,000/- (Rupees Ten Thousand only), (Refundable/ Adjustable).

**Terms and Conditions:**

1. Category wise bids are to be made by all the bidders participating in the auction, as per the list of tyres attached herewith.

2. The difference between each bid must be higher than the former bid with the difference of minimum Rs.10/- or its higher multiples.
3. The bidders participating in the auction will have to deposit the earnest money, fixed at Rs.10,000/- (Refundable/ Adjustable), an hour before the auction, i.e. at 10 am, with the Cashier of this Hon'ble Court. A token/ receipt for that will be issued which needs to be produced before entering the auction venue. Only those bidders having token/ receipt, in lieu of having deposited the token money would be allowed to the Auction venue, i.e. the Old District Court Building, Sector - 17, Chandigarh.
4. Only a single person/ dealer, whose name would be mentioned on that token/ receipt, will be allowed to participate in the auction and no other person would be allowed to participate in the auction.
5. The person/ dealer/ firm with the highest bid will have to submit the full payment of the tyres bought, within an hour of the completion of the auction process, with the Cashier of this Hon'ble Court and will have to lift the purchased items on same day, before 5:00 pm, and no item should be left back, as after the payment, this Office would not be responsible of the items, after the auction process is completed.
6. Using the Official lift for transfer of auctioned tyres is strictly prohibited, as it may be hindrance in the working of the office. Also, the manpower for transfer of tyres has to be arranged by the winning bidder himself.
7. This High Court Office reserves the right to accept or reject any or all the bids without assigning any reason thereof.
8. Any person/ dealer/ firm found to be in violation/ manipulation of the abovementioned rules and regulations, will be resulting in the disqualification of the concerned person/ dealer/ firm and would

be asked to leave the Auction venue immediately and would be debarred forever from any transactions with the Office of the Hon'ble Court, without providing any reason, or so.

9. All the dealers/ firms participating in the Auction are hereby informed that the final decision regarding any/ all the matters relating to the Auction, will be made by the Condemnation Board of this Court, without any explanation, whatsoever.

10. High Court reserves the right to change the terms of the auction, as the case may be, at any stage.

**NOTE-:** All the dealers/firms interested in the prior inspection of the tyres may inspect the tyres only w.e.f. 26.02.2020 to 28.02.2020, between 02:30 P.M. to 04:00 P.M. in the Old District Court Building, Sector - 17, Chandigarh.
