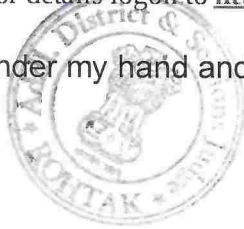
**Claim Petition under Section 166 of the Motor Vehicles Act**
