

Punjab Civil Services (Judicial Branch) Preliminary Examination-2017

A gist of objections/answers suggested by the candidates qua questions/proposed answers in abovesaid examination are uploaded hereunder for information of all concerned for filing of cross-objections, if any.

Online Cross-Objection Module:

1. Any candidate may file online cross-objection(s) through e.mail ID crossobjectionspcs2017@gmail.com against any suggested answer (as per question booklet Code 'A' only, though he/she have attempted questions as per Code B, C or D).
2. The cross-objections are permissible only through E-mail. Objection by way of hard copy, by hand or by post will not be entertained.
3. Filing of cross-objection is permissible till **12.00 noon on 22.01.2017**. No cross-objection will be entertained in any eventuality after the given time. High Court shall not be maintaining E-mail account/data after the expiry of time given for filing of cross-objections.
4. Candidate shall type his/her name, roll number and question no. in the subject box of the E-mail.
5. The cross-objection shall be written in the space given in the E-mail and supported by reasons. Before writing cross-objection and reasons, candidate shall have to write the mandatory particulars as under:-
 - (a) Question No.....
 - (b) Proposed Answer.....
 - (c) Answer suggested by objector(s).....
 - (d) Answer suggested by cross-objector.....
6. Candidate can file more than one cross-objection. Only one cross-objection will be entertained in one E-mail message. For next cross-objection, candidate will have to send new E-mail message. Candidate can send as many E-mails as the cross-objections preferred.

7. If candidate wants to support his cross-objection by way of reference to any judgment or book, the complete citation of the judgment; title of the book, name of the Author, year or edition of publication, name of publisher and relevant page number must be mentioned in the cross-objection. Further such judgment / relevant book page must be uploaded by way of attachment in PDF format only
8. The cross-objections are being entertained in the interest of transparency, fairness and objectivity. Therefore, any attempt to play prank will be viewed seriously.
9. The High Court will not be responsible for any loss of contents, data, delay etc. due to any defect / fault.
10. No cross-objection(s) submitted in violation of these instructions will be entertained.




