In Case, the application of the same accused is listed before the same Hon'ble Bench in view of the aforesaid directions, it will deemed to be listed as per roster.

- Special Division Bench(es) presided by Hon'ble First Judge of the Regular Division Bench(es) will be taken at 10 a.m. i.e. before meeting of respective Regular Division Benches on the given date or Friday as the case may be.
