

ARRANGEMENT IN CURRENT ROSTER W.E.F. 31.10.2023

Hon'ble Mr. Justice Raj Mohan Singh has been transferred to Hon'ble High Court for the State of Madhya Pradesh. Hon'ble Mr. Justice Arvind Singh Sangwan has also been transferred to Hon'ble High Court of Allahabad.
