

Hon'ble the Acting Chief Justice has been pleased to order that during ensuing spell of Dussehra Vacations, First Anticipatory Bail Applications, Cases relating to Life and Liberty (Protection matter of Runaway Couples) and 'any other Urgent Matter' as may be permitted by Hon'ble the Senior most Vacation Judge through Registry; will be entertained on **23.10.2023, 25.10.2023, 26.10.2023 and 27.10.2023**.

Habeas Corpus Petitions will also be entertained from **22.10.2023 to 29.10.2023**.

2. Request for listing the case for the same day or next Court working day in case of First Anticipatory Bail Applications and Protection matters of Runaway Couples as well as taking up of ‘any other Urgent Matter’ including Division Bench matters, if any, will be made before Hon’ble the Senior most Vacation Judge available on the date mentioned only on Court Working days.
3. No filing except First Anticipatory Bail Application, Protection matter of Runaway Couples, Caveat Application u/s 148-A CPC and cases in which mentioning for listing the case during Dussehra Vacations has been allowed by Hon’ble the Senior most Vacation Judge will only be entertained during Dussehra Vacation on 23.10.2023, 25.10.2023, 26.10.2023 and 27.10.2023.

However, Habeas Corpus Petitions will be entertained without mentioning during Dussehra Vacations from 22.10.2023 to 29.10.2023.

Filing of all cases will resume w.e.f. 30.10.2023.

4. All the cases adjourned for the period 21.10.2023 to 29.10.2023 will be listed on 30.10.2023 (*after Dussehra Vacations*).

However, the Bail Applications (*Except Subsequent Bail Applications*) and Suspension of Sentence adjourned for the period 21.10.2023 to 29.10.2023 will be listed for the date so adjourned. The Adjourned Subsequent Bail Application will only be listed subject to the availability of the Hon'ble Judge who had decided the earlier Bail Application.

Moreover, the cases which have been adjourned for the period 21.10.2023 to 29.10.2023 and wherein a written request has been made by the Ld. Counsel for the petitioner to the registry one day prior to listing of the case, the same shall also be listed as per roster before the Hon'ble Vacation Bench.

5. The fresh **Subsequent Bail Application** will be entertained and listed during Dussehra Vacations only subject to the availability of the Hon'ble Judge who decided the earlier Bail Application.
