

# HIGH COURT OF PUNJAB AND HARYANA AT CHANDIGARH

## ORDER

Dated, Chandigarh, the 21<sup>st</sup> December, 2018

In exercise of the powers conferred under rule 6(1)(c) of the Haryana Superior Judicial Service Rules, 2007, the Governor of Haryana, on the recommendation of this Court, is pleased to appoint the candidates namely **Ms. Karuna Sharma, Ms. Abhilasha Sapra Kohli and Sh. Manish Dua** as Additional District & Sessions Judges in the State of Haryana, purely on provisional basis from the date they take over as such, in the pay scale of ₹ 51,550-1,230-58,930-1380-63,070 plus usual allowances as sanctioned by the Haryana Government from time to time, with further orders that these appointments are subject to the terms and conditions, i.e. **(i)** that they will be governed by the Haryana Superior Judicial Service Rules, 2007 in Haryana as well as other rules/instructions in the matter of leave, conduct, discipline and appeal, medical attendance, provident fund, travelling allowance and all other service matters etc. framed by the Government of Haryana and issued from time to time, **(ii)** the selection/appointment of Ms. Karuna Sharma, Roll No. 1001 is subject to the result of Special Leave to Appeal (C) No. 14156/2015 titled as "Dheeraj Mor Vs. Hon'ble High Court of Delhi" and other connected petitions, which are pending adjudication before the Hon'ble Supreme Court of India, **(iii)** that these appointments are subject to the fulfillment of all necessary conditions laid down in rules. **(iv)** their probation will be governed by Rule 13 of the Haryana Superior Judicial Service Rules, 2007 and they will be on probation for a period of two years, from the date of joining duty as decided by the Hon'ble Punjab and Haryana High Court, Chandigarh.
