Suit for possession by way of specific performance on the basis of agreement to sale date 27.07.2020 executed by the defendant in favour of plaintiff whereby the defendant no.1 agreed to sale the land measuring 12 Marla being 1/2 share land bearing Khasra No.374 (1-4) of khewat no.37 as per copy of jamabandi for the year 2017-18 and mutation no.3711 situated at village Daiyar, Tehsil and Distt. Fatehabad to the plaintiff for a sale consideration of amount Rs.625000/- (Rs. Six Lakh Twenty Five Thousand) and received an amount of Rs.496000/- (Rs. Four Lakh Ninety Six Thousand) vide cheque no.589801 dated 27.07.2020 of State Bank of India of Rs.400000/- (Rs. Four Lakh) and cheque no.589802 dated 27.07.2020 of State Bank of India of Rs.96000/- (Rs. Ninety Six Thousand) as earnest money from plaintiff and fixed the date for execution and registration of sale deed as 26.07.2021 on payment of the remaining sale consideration of Rs.129000/- (Rs. One Lakh Twenty Nine Thousand) and also as consequential relief suit for permanent injunction thereby restraining the defendant no.1 from alienating or creating any encumbrances over the above mentioned land in any manner.
