Suit for Partition of the land measuring 5 kanal 16 marla bearing Khasra no. 125// 20/2 (5-16) Gair Mumkin situated at Basti Bhiwan, Fatehabad, Tehsil and District Fatehabad (in Kranti Nagar Colony, in backside of Kath Mandi, Bighar Road, Fatehabad) owned by plaintiff and defendants no. 1 to 24, by keeping the possession of plaintiff on his residential house in portion of land measuring 3.5 marla which is 7/232 of aforesaid land measuring 5 kanal 16 marla, bounded as, East side of 44 Feet, the house of Seema Rani, West side of 44 Feet, the house of Bindu, North side of 22 Feet, the house of Vidya wife of Ram Sarup and South side of 22 Feet, open street.
