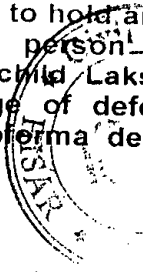

been dissolved by a decree of divorce by mutual consent with an effect of undertaking given to such effect by defendant No.3 AND FOR FURTHER DECLARATION TO THE EFFECT that the action of defendant No.2 vide which the application moved by the plaintiff vide Saral ID:HRBDCORN/2023/00698 dated 05.01.2023 for correction in the birth certificate by reflecting the name of plaintiff as adoptive father of child has been rejected by the defendant No.2 on 27.01.2023 (printed on 22.02.2023) is null & void-ab-initio, against law, without authority, illegal, unlawful, in violation of the relevant rules, vague, evasive and ambiguous and not binding on rights of plaintiff and proforma defendant and the rejection letter is liable to be set aside; WITH CONSEQUENTIAL RELIEF IN THE NATURE OF MANDATORY INJUNCTION issuing directions to the defendant No.2 to correct its record and issue a fresh birth certificate after making necessary corrections therein by adding the name of the plaintiff as adoptive father of minor child Lakshita Soni at the earliest AND FOR CONSEQUENTIAL RELIEF OF PERMANENT INJUNCTION to the effect that the defendant No.3 be restrained from causing any kind of obstruction and interference in the intended change in birth certificate; on the basis of
