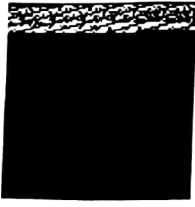

Suit for mandatory injunction directing the defendant no. 1 to 3 to enter and sanction the mutation of Smt. Chatri W/o Manga Ram who was the mother of the plaintiffs qua her agriculture land comprising khewat No. 258//236, Khatauni No. 425 to 433 situated at Village thurana, Distt. Hisar in favour of the plaintiffs pursuant to death of Smt. Chatri on dated 13.01.2010 as the plaintiffs are her only legal heirs and there is no other legal heirs of Smt. Chatri and as such the defendants No. 1 to 3 are legally and lawfully bound to enter and sanction the mutation qua the land of Smt. Chatri in favour of the plaintiffs and for declaration that the entry showing the husband name of Smt. Chatri to be Pyara instead of Sh. Manga Ram is quite wrong, illegal, against law, against facts, without competency, null and void ab-initio, based upon wrong report and has no binding effect upon the rights of the plaintiffs and the same is liable to be corrected by way of mentioning the name of Smt. Chatri to be Manga Ram as Smt. Chatri was the legally wedded wife of Sh. Manga Ram. On the basis of evidence of all kinds, oral as well as documentary of every description.
