<p><b>Suit for declaration to the effect that farad badar no. 2 dated 25.04.2014 of village Nirjan Tehsil and Distt Jind is illegal, unlawful, nonest, null and void without jurisdiction and authority and is not binding on the rights of plaintiffs and is liable to be set aside and be deemed as no such farad badar has been prepared and further for declaration to the effect that the plaintiffs are entitled to get the revenue record/jamabandi of the land comprised in khewat no. 295 khata no. 356 amd 357 total measuring 74 kanals 15 marlas situated in the area of village Nirjan Tehsil and Distt Jind as per jamabandi for the year 2017-18 and also of the land comprised in khewat no. 255 khata no. 318 to 326 total measuring 92 kanals 16 marlas situated in the area of village Nirjan Tehsil and Distt Jind as per jamabandi for the year 2012-13 on the basis of jamabandi for the year 2007-08 of the land comprise din khewat no. 217 khata no. 282 to 290 total measuring 92 kanals 17 marlas situated in the area of village Nirjan Tehsil and Distt Jind and for mandatory injunction directing defendants set no 1 to correct the jamabandi for the year 2012-13 and 2017-18 of the aforesaid land deeming and considering as if no such farad badar no 2 dated 25.01.2014 has been prepared and passed and for permanent injunction restraining defendants set no 1 from carrying on the entries in the incoming jamabandi of the aforesaid land on the basis of amended/modified jamabandi for the year 2012-13 and 2017-18 of the aforesaid land as per farad badar no 2 dated 25.01.2014 and further restraining defendants set no 2 from alienating specific portion out of the aforesaid land and in excess of their share and from transferring possession of any specific portion of the aforesaid land to any other person without getting the aforesaid land partitioned.</b></p> <p style="text-align: right;"><b>CNR No. HRJN02-001264-2022</b> <b>Next Date:- 11-11-2024</b></p>
