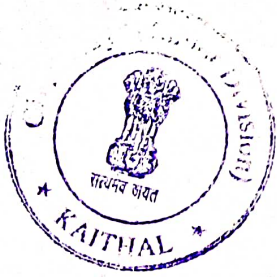
Whereas in the above noted **Suit For Partition and Permanent Injunction as Consequential relief**, it has been proved to the satisfaction of this court that the above
