Suit for declaration and possession to the effect that the plaintiffs are owners in possession of 1/4 share in equal share and proforma defendants no.72 and 73 are owners and in possession of 1/4 share in equal share and proforma defendants no.74 to 76 are owners and in possession of 1/4 share in equal shares and the proforma defendants no.77 and 78 are owners and in possession of 1/4 share in equal shares being the LR's of predecessors of Smt. Ram Rakhi daughter of Sedhu @ Sethu son of Shri Kumbha Ram (wife of Shri Lekh Ram) of land measuring comprised in Khewat No.277 Min Khatuni No.437 to 445 SQ. No.62 Killa No.15/2(5-18), 16/1(7-12), 20(8-0), 21(8-0), 22(8-0) 23(8-0), 24/1(7-13), 25/2(7-12), Sq. No.63 Killa No.11/2(4-0), 20(8-0), 21(8-0), Sq no.71 Killa No.1/1(2-4), 10/2(2-6), Sq. No.72 Killa No.5(8-0), Sq. No.62 Killa No.15/1(0-7), 16/2(0-8), 24/2(0-7), 25/1(0-8), Sq. No.70 Killa No.1/1(0-9), 2/1/1(0-7), Sq. No.71 Killa No.2/2(0-8), 3/1(0-9) 4/1(0-9), 5/1(0-9), 9/1(0-8), vide Jamabandi for the year 2007-08 situated at Village Kutiana Tehsil and District Sirsa since after the death of Sethu @ Sedhu (died in the year 1960-61), father of Ram Rakhi (died in the year 1986-87) as the inheritance never remains in abeyance and for opening the inheritance there is no limitation as well, and the mutation No.1262 as per the then prevailing Jamabandi for the year 1978-79 of Village Kutiana is also liable to be set aside and all the subsequent interse changes/ partition / transfers of every type on the basis of mutation No.1262 in revenue papers are wrong as a result of conspiracy, misrepresentation, concealment of facts as well as interse collusion of fathers brother and nephews allegedly of Sedhu and thereafter the sale deed nos.100 dated 12-04-2013 and sale deed No.68 dated 08-04-2013 in favour of defendant no.54 by defendants in this manner all the mutations/changes in the revenue entries in the subsequent relevant revenue records, namely Jamabandi and Girdawari etc. are void ab-initio, nonest and not binding on the hereditary rights of the plaintiffs and proforma defendants and liable to be declared so and set aside and as a consequential relief of permanent injunction restraining the defendants from further alienating the suit land by way of any known mode of transfer and for possession, on the basis of evidence of every description oral as well as documentary.
