The instant application has been filed seeking permission to serve respondent No.2 through mode of substituted service by publication in the local newspaper.

A perusal of the records shows that vide order dated 15.12.2018 the application bearing CM No.23474-CII-2018 was allowed in the following terms:-

*"For the reasons mentioned in the application and the arguments addressed, liberty is afforded to the applicant-appellant to serve respondent No. 2 by way of substituted service through publication in two newspapers, one in vernacular and one in English as per list approved by the High Court, having wide circulation at the last known address of respondent No. 2 for 11.03.2019.*

*Application is disposed of."*

Learned counsel for the applicant-appellant submits that due to inadvertence and lack of funds, the publication in the English newspaper could not be effected. Hence, he prays for permission to serve respondent No.2 through publication in some local newspaper(vernacular only).

Having heard learned counsel for the applicant-appellant and perusing the record, the applicant-appellant is afforded one more opportunity to serve respondent No.2 by way of substituted service through publication in two newspapers, one in vernacular and one in English as per list approved by the High Court, having wide circulation around the last

known address of respondent No.2 for 16.12.2022.

The application stands disposed of.

Publication be effected on or before 15.11.2022 and compliance affidavit along with copies of the publication effected be filed in the Registry at least one week before the date fixed.

Main case be also listed on the said date.
