**IMPORTANT INSTRUCTIONS FOR CANDIDATES**

1. The candidate should check the Admit Card very carefully and discrepancies if any, be brought to the notice of the S.S.S.C., without any delay.
2. Please reach the venue strictly at the given **REPORTING TIME**. Anyone coming after the **REPORTING TIME** will not be allowed to take the test/ interview.
3. Candidate to ensure that he fulfils the eligibility conditions specified in advertisement before appearing in the test. His appearance in the test is purely provisional. Mere appearance and qualifying the test shall not confer any right for appointment.
4. No change should be made in the Admit Card by the Candidate.
5. The candidate has to produce his/her admit card along with original photo identity proof at the venue of examination, which may be Aadhar Card, Driving license, Voter ID, Passport or PAN Card etc. Entry will not be allowed without admit card and original photo identity proof.
6. No candidate will be allowed to appear in the test without admit card, original driving licence (LTV) and original photo identity proof.
7. **Candidate has to affix his attested photograph on admit card which he had uploaded while filling the online form otherwise the candidate may not be allowed to appear in the test/ interview.**
8. Biometric impression of each candidate will be taken at the venue of practical driving test/interview.

9. Candidate is advised to take print out of his Admit Card preferably in **COLOURED FORMAT**.
10. Candidate should bring the following testimonials in original together with one set of attested copies of the documents :-
- a. Proof of having passed middle class examination (Detailed marks sheet). The candidates who have not passed middle standard examination from any education board will be required to submit certificate of qualification showing details of subject counter signed by the concerned District Education Officer.
  - b. Proof of date of birth certificate/Matric certificate
  - c. In case of Government employee. no objection certificate issued by the employer.
  - d. Original and copy of photo identity proof.
  - e. Two passport size photographs, one duly attested by Gazetted Officer and other one unattested which was uploaded at the time of online submission of application.
  - f. **Two year experience certificate of driving as mentioned** at the time of online submission on application.
11. Candidate shall be liable for any damage caused by him to the vehicle during the Practical Driving Test.
12. Candidate is advised to observe due care to avoid any injury / damage / loss to either himself or others during the process of Practical Driving Test. S.S.S.C. will not be responsible for any loss / injury whether direct or consequential suffered by any candidate.
13. No repeat / second chance / relaxation in standard for Practical Driving Test will be granted in any circumstances.
14. No TA/DA will be paid.
