NOTICE FOR CANDIDATES OF HARYANA SUPERIOR JUDICIAL SERVICE EXAM-2017.

Some candidates while applying in response to the First Notification and the subsequent corrigendums have submitted copy of Income Tax Returns pertaining to different assessment years. Similarly, some candidates have submitted the List of Court Cases of different periods which are not verifiable.

Hon'ble the Recruitment Committee (Superior Judicial Service) has decided that prior to commencement of evaluation of the answer sheets of Haryana Superior Judicial Service Examination held from 10.02.2017 to 12.02.2017, the eligibility qua Income and Number of Court Cases of the candidates who have been provisionally allowed and appeared in the examination, be determined so as to lend uniformity to the process.

In order to ensure parity and uniformity, Hon'ble the Committee has been pleased to order that all the candidates who appeared in all the five papers of Haryana Superior Judicial Service Examination-2017 held from 10.02.2017 to 12.02.2017, irrespective of the fact whether they have applied under the original notification or the subsequent corrigendums, are hereby directed to submit the following information/documents by on or before 21.03.2017 up-to 05.00 p.m. for determination of eligibility under clause 2(bb) of the Notification dated 16.07.2015:-

All the candidates (who appeared in all the five papers of the aforesaid Exam) shall furnish self-attested copies of their Income Tax Returns for any three years out of the four Assessment Years i.e. 2012-13, 2013-14, 2014-15 and 2015-16.

A candidate, who meets income criteria for any three years out of the aforesaid four assessment years, will be considered as eligible. All the candidates (who appeared in the five papers of the aforesaid Exam) shall furnish sworn affidavit as per Annexure '1' duly supported with year-wise lists of cases conducted by them in court(s). List shall contain case number, date of institution, title and the name of Court. Candidates are warned to be careful while submitting Affidavit and the supported lists, as in case on verification the contents of the affidavit/list(s) are found to be false, not only their candidature will be cancelled but it may also lead to their prosecution. The affidavit shall be on stamp paper of Rs.15/- duly attested by Magistrate 1st Class.

A candidate, who meets court cases criteria for any three years out of the aforesaid four years, will be considered as eligible.

- The 'in-service' candidates who have completed 3 years' service and are otherwise eligible, are exempted from submitting the income tax returns and lists of number of court cases. However, the candidates who have less than three years service prior to date of notification but were otherwise eligible before joining the service, shall submit copies of income-tax returns and the list(s) of number of cases for three years minus the service period.
- 4. The candidates are further informed that the result of Written Examination of those candidates, who fail to furnish the requisite information/documents as aforesaid within the stipulated period, shall be withheld.

The requisite information/documents should reach the Coordination Branch (Receipt & Dispatch), Punjab and Haryana High Court,
Chandigarh on or before 21.03.2017 up-to 05.00 p.m. The envelope
should be super-scribed with the words, "Haryana Superior Judicial
Service Examination-2017". High Court shall not be responsible in any
way for postal or other type of delay. Delayed information/documents
shall not be considered under any circumstances and no further
opportunity for this purpose shall be provided.
