## **PUBLIC NOTICE**

### **Testimonials Checking for filling up 235 Posts of Peon on the Establishment of this High Court**

It is for information of all concerned candidates that testimonials for filling up 235 posts of Peon on the establishment of Hon'ble Punjab and Haryana High Court at Chandigarh shall be checked from 12.05.2026 to 14.05.2026 at Recruitment Cell, 3<sup>rd</sup> floor, Old District Court Building, Sector-17, Chandigarh. The schedule (date/time) for testimonials checking is attached herewith this notice.

Candidates must bring the following documents (in original), along-with one set of self-attested copies of these documents at the time of testimonials checking: -

1. Proof of Date of Birth (Matriculation Certificate showing Date of Birth/Date of Birth Certificate issued by Registrar of Birth and Death).
2. Middle/Matriculation/10+2 detailed marksheets, whichever is applicable.
3. Candidate belonging to reserved category i.e. SC/ST/BC, Ex-servicemen, PWD must bring document in proof of their category. Further, the candidates belonging to PWD category must bring the relevant document showing percentage of their disability.
4. Candidates belonging to BC Category shall ensure that they fulfill necessary conditions as to exclusion of 'Creamy Layer' as per Rules applicable in their respective States and shall, besides production of latest BC certificate, have to furnish requisite undertaking on format Affidavit/Undertaking (Annexure-I) appended with detailed employment notice/advertisement.
5. Candidates, who are working in Government Departments/Semi Government Departments/PSU/Corporations/Boards, shall have to submit Forwarding Letter/No Objection Certificate on format (Annexure-II) appended with detailed employment notice/advertisement, issued by respective head of the Department.
6. Candidates shall have to furnish undertaking on format Affidavit/Undertaking (Annexure-III) appended with detailed employment notice/advertisement giving information with regard to any of their close relative(s) working in the Establishment of the High Court or any Subordinate Court in the States of Punjab, Haryana and U.T. Chandigarh. The close relative means Husband, Wife, Father, Father-in-Law, Mother, Mother-in-Law, Brother, Brother-in-Law, Sister, Sister-in-Law.
7. Candidates shall have to furnish Affidavit/Undertaking (Annexure-IV) appended with detailed employment notice/advertisement about their previous employment(s), if any. Previous employment(s) means any employment(s) which candidate had already left in Government

Departments/ Semi-Government Departments/ Corporations/ Boards before filling up the online application form.

8. Candidates shall have to furnish an affidavit/undertaking (Annexure-V) appended with detailed employment notice/advertisement to the effect that their qualification is not more than (10+2) on the last date of filling up the application form and in case of concealment regarding above fact by any candidate, he/she shall be liable for criminal action and for termination from service, if he/she gets finally selected.

**Note:-**

- i. Biometrics of candidates shall be verified at the time of testimonials checking.
- ii. Candidates shall ensure that he/she fulfills the eligibility conditions as per advertisement before appearing for the testimonials checking. His/her appearance for the testimonials checking is purely provisional. Merely because a candidate is called for testimonials checking does not imply that he/she is eligible for appointment.
- iii. Candidates must bring their two latest passport size photographs.
- iv. If a candidate fails to produce his/her original certificates or fails to appear for testimonials checking on the date fixed, it may result in cancellation of his/her candidature for the posts of Peon.
- v. The date/time/venue of testimonials checking shall not be changed in any circumstance.
- vi. No TA/DA shall be given to any candidate for appearing for the testimonials checking.
- vii. Relevant annexures are attached herewith for information of the candidates.
