**NOTE:-**

Hon'ble Judges sitting in Hon'ble Division Benches after exhausting their lists may sit singly for taking up Single Bench cases.

- Special Benches will be taken up on all Fridays or as per date given by the Hon'ble Special Bench itself.
- Mentioning of the cases to be listed before Hon'ble Division Bench -1, Hon'ble Special Division Bench presided over by Hon'ble the Chief Justice and the cases on the board of Hon'ble the Chief Justice will be made before before Hon'ble the Chief Justice.

Mentioning of Civil Writ Petitions and Civil cases (*except the cases to be listed before Hon'ble Division Bench -1, Hon'ble Special Division Bench presided over by Hon'ble the Chief Justice and the cases on the board of Hon'ble the Chief Justice*) will be made before the Hon'ble Senior Judge of DB-II.

Mentioning of criminal cases will be made before Hon'ble Senior Judge of DB-III.

In case Hon'ble the chief Justice is not available, the mentioning of cases to be listed before Hon'ble Division Bench -1 will also be made before the Hon'ble Senior Judge of DB-II and so on, as per availability.

In case the Hon'ble Senior Judge of DB-II hearing the mentioning of the Civil Writ Petitions & Civil Cases or the Hon'ble Senior Judge of DB-III hearing the mentioning of the Criminal cases respectively, is not available; the mentioning of such cases which is to be made before DB-II or DB-III as the case may be, will be made before Hon'ble Senior Judge of DB-IV and so on, as per availability.

However, the cases which are already listed in urgent/motion/regular hearing before any Hon'ble Bench, the mentioning regarding the same will be made before the same Hon'ble Bench. In case the said Hon'ble Judge is not holding court on that day, such mentioning will be made before the senior most Hon'ble Judge available in the Roster i.e. DB, Writ (SB), Civil (SB), Criminal (SB) roster respectively.

- In case the first Hon'ble Judge of the Division Bench is not holding the court the urgent cases will be put before the next Division Bench. e.g. the matters of 1<sup>st</sup> DB will be taken by the 2<sup>nd</sup> DB and so on.

However, In case the first Hon'ble Judge of DB-IX is not holding the court, the matters will be put before DB-VIII.

- Cases upto the year 1995, cases relating to Senior Citizens, Crime against Women, differently abled persons, Juveniles, Marginalized Sections of society, Prevention of Corruption Act, cases in which proceedings before lower Courts have been stayed and remand cases from Hon'ble the Supreme Court will be taken up on priority basis.
- Ordinarily filed RSAs up to the year 2018 wherein notice is yet to be issued will be shown in urgent list.
- All Writ Petitions challenging constitutional validity of any Act, statutory rules or notification filed before **01.01.2019** will be listed before the Hon'ble Division bench as per the subject matter of roster assigned.
- The application(s) for recalling/modification/correction/clarification/rectification waiver of costs etc. in the pending case unless specifically styled as Review Application, will be listed as per Roster.  
The application for vacation of order of interim bail/vacation of stay in pending criminal case/petition shall also be listed as per roster.
- The successive bail applications U/ss 438 & 439 C.r.P.C of the same accused and application for cancellation of bail U/s 439 (2) C.r.P.C. will be listed before the same Hon'ble Bench which decided the earlier bail applications, unless the Hon'ble Judge/Judges has/have transferred or superannuated, irrespective of the subject matter specifically assigned to the said Hon'ble Bench/Hon'ble Judge in the Roster.  
All the pending successive bail applications U/ss 438 & 439 C.r.P.C of the same accused and application for cancellation of bail U/s 439 (2) C.r.P.C. which have been now listed before the other Hon'ble Benches, shall be listed as per the above directions.
- Special Division Bench(es) presided by Hon'ble First Judge of the Regular Division Bench (es) will be taken at 10 a.m. i.e. before meeting of respective Regular Division Benches on the given date or Friday as the case may be.  
In case, there are two or more Special Division Benches with Hon'ble First Judge of the Division Bench as a member, the Special Division Benches will be taken up as per the Seniority of Hon'ble Second Judge.
- In supersession of earlier orders as to listing of case (s) passed by Hon'ble the Chief Justice or as per his orders; all the cases which can now be listed as per roster in the current roster, will be listed as per roster.
- Specially constituted Benches to hear murder references along with Criminal Appeals shall continue.

**NOTE: The date from which this roster will be made effective, shall be notified later on. In the meanwhile, the present arrangement of nomination of Benches during the Covid-19 Period shall continue.**
