- All the Criminal Cases and Contempt Petitions from the year 1996 to 2005 will also be listed in the Urgent Motion Cause List. If cases from the year 2006 onwards are ordered to be heard alongwith cases from the year 1996 to 2005 or vice-versa, then both the matters will be listed in Urgent Motion Cause List.
- All the LPA and Tax Appeals filed in the Ordinary motion will be listed in the Urgent List at the first instance.
- All Civil and Criminal Cases registered upto the year 2023 (*except where stay of execution of decree against the final judgment and decree has been ordered and where appeal or revision is against the final judgment*) in which passing of interim order by this court has the effect of staying final decision by the trial court or First Appellate Court or the Executing Court will be listed in the Urgent Motion Cause List.

- All the Cases pertaining to Senior Citizens who have attained the age of 91 years or above will be listed in the Urgent Motion Cause List.
- Admitted cases (*except Criminal Cases and Contempt Petitions*) from the year 1996 to 2002 will be listed in the Ordinary Motion Cause List.
- FAO (MACT) matters filed for enhancement wherein Notice of Motion has not been issued shall be listed in the Urgent motion Cause list.
- All the Bail Applications upto the year 2025 will be listed in Urgent motion Cause list.
- All the Applications for Suspension of Sentence upto the year 2024 will be listed in Urgent motion Cause list.
- In the event any application for Suspension of Sentence is ordered to be heard along with main appeal and the same is admitted (on/off board), then both the appeal as well as application for suspension of sentence will be shown in the urgent/ordinary motion cause list.
- All admitted Criminal Revisions pending for more than 10 years i.e. cases from the year 2006 to 2015 will be listed in the Ordinary Motion Cause List.

All admitted cases filed under Negotiable Instruments Act, 1881 pending for more than 3 years i.e. cases from the year 2006 to 2022 will also be listed in Ordinary Motion Cause List.
- All admitted Execution First Appeal, Execution Second Appeal, Second Appeal from Order, Tax Matters, Contempt Appeal pending for more than 5 years i.e. cases from the year 2000 to 2020; all the admitted Probate, Arbitration Cases, Company Appeals, Transfer Applications, Civil Suit- Original Side, Civil Reference pending for more than 5 years i.e. cases from the year 1996 to 2020 and Criminal Revision (Family Court), Criminal Writ Petitions, Murder Reference, Criminal Reference pending for more than 5 years i.e. cases from the year 2006 to 2020 will be listed in Ordinary Motion Cause List.
- All the Admitted Cases filed by or against the sitting/former MPs/MLAs will be listed in the ordinary motion list.

- All the Execution Applications registered upto the year 2025 will be listed in Urgent motion cause list.
- The application(s) for placing on record the document(s) without any further prayer except exemption from filing certified copy(ies), in pending case(s) will be listed on the date when the main case is to be listed.
- The application(s) in decided cases shall be listed before the same Hon'ble Bench who was/were member(s) of the said Hon'ble Bench.

However, The Execution Applications filed in decided Civil Writ Petitions and Applications for revival in decided Contempt Petitions shall be listed as per roster.

- The application(s) for recalling/modification/correction/clarification/rectification/waiver of costs etc., in the pending case unless specifically styled as Review Application, will be listed as per Roster.

The application(s) for vacation of order of interim bail/vacation of stay in pending criminal case/petition shall also be listed as per roster.

- **Listing of Criminal Cases:**

- (i) All the matters arising out of one FIR/Complaint shall be listed as per roster before one Hon'ble Bench.

In case any Bail Application in a FIR/Complaint is pending before any Hon'ble Bench sitting in roster, then all the other matters arising out of the same FIR/Complaint shall also be listed before the same Hon'ble Bench where Bail Application(s) is pending being the lead case.

- (ii) In case any Revision, Appeal, Quashing Petition and Direction Petition or any other case is being listed prior to listing of Bail Application, then the said case will also be listed before the same Hon'ble Bench where Bail Application is being pending/decided, if available in roster.

- (iii) The Subsequent Bail Application(s) filed under section 102 of Juvenile Justice (Care and Protection of Children) Act, 2015 filed in the form of Criminal Revision(s), under section 14A(2) of Scheduled Caste & Scheduled Tribes (Prevention of Atrocities) Act, 1989, as amended by the Amendment Act, 2015 and under section 21 of the National Investigation Agency Act filed in the form of Criminal Appeal(s) and the Subsequent Bail Application(s) under section 438 &

439 Cr.P.C. (u/s 482 & 483 of Bharatiya Nagarik Suraksha Sanhita, 2023) as well as Application(s) for Interim Bail(s) and Application(s) for Cancellation of Bail under section 439 (2) Cr.P.C. (u/s 483 (3) of the Bharatiya Nagarik Suraksha Sanhita, 2023) shall be listed before the same Hon'ble Bench who had earlier decided (on merit or disposed of/ dismissed as withdrawn for non-prosecution/ not pressed) any of the bail application arising out of the same FIR/Complaint, if available in roster.

- (iv) In case, any pending matter(s) in an FIR/Complaint which is required to be allocated afresh before Hon'ble Bench and the same can be listed before two or more Hon'ble Benches, available in roster due to their previous listing status, then the said matter will be placed before Senior Hon'ble Judge amongst them as per roster.
- (v) Subsequent Application(s) for Suspension of Sentence under section 389 Cr.P.C. (u/s 430 of the Bharatiya Nagarik Suraksha Sanhita, 2023) shall also be listed before the same Hon'ble Division/ Single Bench, who had earlier decided (on merit or disposed of/ dismissed as withdrawn for non-prosecution/not pressed) the Application for Suspension of Sentence filed by the same accused, if the same composition of Hon'ble Judges is available in roster.
- Hon'ble Special Division Benches will be taken up post lunch on the given date or Friday, as the case may be. However, in case, there are two or more Hon'ble Special Division Benches with Hon'ble Senior Judge of the Division Bench as a member, the Special Division Benches will be taken up as per the Seniority of Hon'ble Second Judge.
- The case(s) which is/are pending in urgent/ordinary motion hearing and ordered to be listed along with admitted case(s), without passing order to the effect of their admission, will be listed in urgent/ordinary motion hearing along with admitted case(s) before concerned Hon'ble Benches.
- The case(s) which have been kept as 'Part-Heard' by the Hon'ble Bench, the said order shall be given effect to only for a month from the first date of passing the said order by the Hon'ble Bench for the purpose of listing.

No matter shall be presumed to be 'Part-Heard' unless it is specifically mentioned in the order by the Hon'ble Bench to be kept as 'Part-Heard'.

- All the matters which, after having been reserved for pronouncement of order/judgement, were/are ordered to be listed for re-hearing/ re-listing/ adjourned for next date of hearing for any purpose, before pronouncing an order/ Judgement, shall be put up before Hon'ble the Chief Justice for listing before an appropriate Hon'ble Bench.
- All the matters which have been restored, remanded back or returned by the Lok Adalat to Hon'ble High Court will be listed as per roster, as per their last listing status.
- In supersession of earlier order(s) as to listing of case(s) passed by Hon'ble the Chief Justice or as per the Hon'ble the Chief Justice's order(s); all the case(s) which can now be listed as per roster in the current roster, will be listed as per roster.
- Specifically directed matter(s) may be assigned by Hon'ble the Chief Justice to any of the above Benches or any of the Hon'ble Judges sitting singly or to a specifically constituted Bench.
