

Hon'ble the Chief Justice has been pleased to order that during ensuing spell of Baisakhi Vacations, First Anticipatory Bail Applications, Cases relating to Life and Liberty (Protection matter of Runaway Couples) and 'any other Urgent Matter' as may be permitted by Hon'ble the Senior most Vacation Judge through Registry; will be entertained on 31.03.2023, 03.04.2023, 05.04.2023 and 06.04.2023.

Habeas Corpus Petitions will also be entertained from 30.03.2023 to 09.04.2023.

  - (i) First Anticipatory Bail Applications and Protection matters of Runaway Couples filed on 27.03.2023 (*after 12.00 Noon*), 28.03.2023 and 29.03.2023 (*before 12.00 Noon*) wherein request for listing the same on 31.03.2023 is made on Urgent form will be listed on 31.03.2023.
  - (ii) First Anticipatory Bail Applications and Protection matters of Runaway Couples filed on 29.03.2023 (*after 12.00 Noon*) and 31.03.2023 (*before 12.00 Noon*) wherein request for listing the same during Baisakhi Vacations is made on Urgent form will be listed on 03.04.2023.
  - (iii) First Anticipatory Bail Applications and Protection matters of Runaway Couples filed on 31.03.2023 (*after 12.00 Noon*) and 01.04.2023 (*before 12.00 Noon*) wherein request for listing the same during Baisakhi Vacations is made on Urgent form will be listed on 05.04.2023.
  - (iv) First Anticipatory Bail Applications and Protection matters of Runaway Couples filed on 01.04.2023 (*after 12.00 Noon*) and 03.04.2023 (*before 12.00 Noon*) wherein request for listing the same during Baisakhi Vacations is made on Urgent form will be listed on 06.04.2023.
