## +HIGH COURT OF PUNJAB AND HARYANA AT CHANDIGARH ORDER

In exercise of the powers conferred under rule 6(1)(c) of the Haryana Superior Judicial Service Rules, 2007, the Governor of Haryana, on the recommendation of this Court, is pleased to appoint the candidates namely Sh. These appointments are subject to the successful completion of probation period as per rules; (iv) that their appointment will be subject to the outcome of court case, if any, instituted/may be instituted in connection with their selection/appointment.
